LIHEAP (Low Income Home Energy Assistance Program) - General Information

Applications are usually accepted October 1 - April 30 of each heating season. The following items are usually required:

► Complete **all sections** of the application, including your signature. Items that don't apply should be marked "none" or "n/a", not left blank.

▶ Include everyone who resides in the home, even if they just moved in and/or are considered a "separate household" for other programs.



Recent bill or "letter of service" from your one main heating provider and recent electricity bill.

► Verification of <u>all income</u>, from <u>all sources</u>, for <u>all current household members</u> – see below.

▶ <u>All pages</u> of a recent statement – that MUST include ALL transactions for the ENTIRE month prior to the month you apply for LIHEAP - for all bank/credit union accounts. Verification of the current balance of all Direct Express cards, ReliaCards, Direct Deposit payroll cards, CDs, IRAs, stocks, bonds, investments, TSAs, 401(k)s, 403(b)s, or any other retirement/investment accounts.
